Mobile Application Privacy Policy Revised May 2019

This privacy policy governs your use of a software application ("Application") on a mobile device that was created by Neurotelli Technologies Inc The Application includes a fighting game called Munkee Kissin Dunkee 1 and 2 and a Learn to code adventure game called Code Laamaa.

What information does the Application obtain and how is it used?

User Provided Information – These applications may collect device and advertising identifier information for the purpose of sending in game ads to the user. As well, in game statistics including level, coins, xp, health and others are collected and stored on a third party server for the purposes of saving game status of the user. It will also be used for research purposes to determine where future game improvements may be made.

Automatically Collected Information - In addition, the Application may collect certain information automatically, such as app opens, app installs, and loading of each game outlined above. All information is collected is anonymous and no personal information is collected. These anonymous statistics are collected on servers operated by Parse.com.

Does the Application collect precise real time location information of the device?

This Application may collect precise information about the location of your mobile device. See next section on third parties.

Do third parties see and/or have access to information obtained by the Application?

Yes. We will share your information with third parties only in the ways that are described in this privacy statement.

The applications use 2 third party services, Unity and Game Sparks to collect personal and game information related above. The only personal information collected are location and device/advertising identifiers as discussed above.

We may disclose User Provided and Automatically Collected Information:

- * as required by law, such as to comply with a subpoena, or similar legal process;
- * when we believe in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a government request;
- * with our trusted services providers who work on our behalf, do not have an independent use of the information we disclose to them, and have agreed to adhere

to the rules set forth in this privacy statement.

- * if Neurotelli Technologies Inc. is involved in a merger, acquisition, or sale of all or a portion of its assets, a prominent notice on our Web site of any change in ownership or uses of this information,
- to advertisers and third party advertising networks and analytics companies as described below under the Section entitled Automatic Data Collection and Advertising.

Automatic Data Collection and Advertising

This Application is supported via advertising, and collects data to help the Application serve ads. We may work with analytics companies to help us understand how the Application is being used, such as the frequency and duration of usage. We work with advertisers and third party advertising networks, who need to know how you interact with advertising provided in the Application which helps us keep the cost of the Application low or free.

Advertisers and advertising networks use some of the information collected by the Application, including the unique identification ID of your mobile

These third parties may also obtain information about other applications you've downloaded to your mobile device, the mobile websites you visit, your non-precise location information (e.g., your zip code), and other non-precise location information in order to help analyze and serve anonymous targeted advertising on the Application and elsewhere.

We may also share encrypted versions of information you have provided in order to enable our partners to append other available information about you for analysis or advertising related use.

Please note that some or all of the User Provided Data may be required in order for the Application to function properly, and we may be required to retain certain information by law.
